





Strategy #2: Family Limited Partnership



Valuation Discounts

- Limited partnership units are valued at 20–40% less than the assets they represent
- \$5 million in business interest may be discounted to \$3-4MM for tax purposes

Valuation discounts are for illustrative purposes only and can vary greatly, depending on the business/owner's location and local IRS evaluations (specifically the IRS agent's experience and allowances). Strategy #3: Grantor Related Annuity Trusts (GRATs)

Grantor contributes asset to GRAT

GRAT distributes annuity payments (trust property) to Grantor

GRAT

Remainder to Beneficiaries
