### Why Cash Balance and Why Now?

| Rates                      | 2012 | 2014  |
|----------------------------|------|-------|
| Investment tax*            | 0%   | 3.8%  |
| Highest income tax         | 35%  | 39.6% |
| Medicare tax**             | 2.9% | 3.8%  |
| Capital gains/Dividend tax | 15%  | 23.8% |

\* Investment Income tax on all unearned income (interest, dividends, gains, rents & royalties, etc.)

\*\* Medicare tax for individuals is 1.45%. Most company structures require an Employer matching amount of
1.45%. Most of these taxes applied on high wage earners earning >\$250k, AGI, filing jointly.

Most desirable type of deduction - Reduces AGI

• Qualified Retirement Plan Contributions

#### **Below The Line Deductions**

Many limitations - Subject to phaseouts.\*

- Charitable Contributions
- State Tax
- Property Taxes
- Mortgage Interest

Subject to phase outs based on income > \$250,000(Single) or >\$300,000(Married filing jointly)
